Professor Emeritus of Child and Adolescent Psychiatry at the University of Geneva and at the University of Lausanne; Former Director of the Department of psychiatry, University of Geneva; Former Head of the Department of Child and Adolescent Psychiatry, University Hospital of Geneva, after having first held the posts of full Professor of child dabs adolescent psychiatry at the University of Lausanne (UNIL), Vice-Dean of the Faculty of Biology and Medicine at UNIL, and Head of the University Department of Child and Adolescent Psychiatry at the Centre Hospitalier Universitaire Vaudois (CHUV).

David Archard is Chair of the Nuffield Council on Bioethics and Emeritus Professor of Philosophy at Queen's University Belfast. He has previously taught at the Universities of Ulster, St Andrews and Lancaster. He is Honorary Vice-President of the Society for Applied Ethics and was a member of the Kingdom's Human Fertilisation and Embryology Authority (2005 –2016). He is a current member of the Clinical Ethics Committee, Great Ormond Street Hospital. He has been a Visiting Professor at the Universities of Bergen, Chinese University of Hong Kong, Beijing, South Florida, and Zurich. He has published extensively in applied ethics, legal philosophy and political philosophy, especially on the topics of children, family and the state, sexual consent, nationalism, and the relation of philosophy to public policy.

Laurent CHAMBAUD

Dr. Laurent Chambaud is the dean of EHESP French School of Public Health since april 2013. Dean Chambaud is a public health physician and former advisor to Ms. Marisol Touraine, the Minister of Social Affairs and Health. He began his career in the service of maternal and child health (MCH) in 1979. From 1980 to 1987, he practiced as a public health physician and obtained a Master of Community Health at the University of Montreal in Quebec.

Dean Chambaud was trained as a medical inspector of public health at the National School of Public Health (NPHS) in 1988, and practiced at the Departmental Directorate of Health and Social Affairs of Finistère until 1990. Following his position as a medical inspector of public health, Dean Chambaud taught at NPHS for six years.

In 1996, Dean Chambaud was appointed national expert seconded to the European Commission and the project coordinator for the establishment of the National Institute of Health Surveillance (INVS) and director of the Departmental Sanitary and Social Affairs Board of Mayenne in 1998.

From 2002 to 2006, he directed the Regional Directorate of Health and Social Affairs of Franche-Comté. After passing the General Inspectorate of Social Affairs from 2006 to 2010, Dean Laurent Chambaud was appointed director of the Public Health Regional Health Agency of Ile-de-France, and joined the cabinet of Ms. Marisol Touraine.



Raja CHATILA



Professor Emeritus of Artificial Intelligence, Robotics and IT Ethics at Sorbonne University in Paris. He is former director of the SMART Laboratory of Excellence on Human-Machine Interactions and of the Institute of Intelligent Systems and Robotics. He is co-chair of the Responsible Al Working group of the Global Partnership on Al (GPAI). He is chair of the IEEE Global Initiative on Ethics of Autonomous and Intelligent Systems and member of the French National Pilot Committee on Digital Ethics (CNPEN).

He is an IEEE Fellow and recipient of the IEEE Robotics and Automation Society Pioneer Award.

Jean-François DELFRAISSY



Immunologist, he is a specialist in HIV and emerging viruses. He was director of the ANRS (France Recherche Nord&sud Sida-hiv Hepatites) and of the Institute of Immunology and Infectious Diseases (Aviesan-Inserm) until the end of 2016. In 2014, he was appointed interdepartmental coordinator of the response to the Ebola epidemic. He was Head of the Department of Internal Medicine at the Paris Sud University Hospital (AP-HP), and Professor at the University of Paris Sud Saclay. Prof. Delfraissy has chaired several international scientific councils on HIV/AIDS as well as a series of international congresses dedicated to infectious disease research such as the IAS World Conference in July 2017 in Paris. He has published more than 500 articles in the field of immunology, internal medicine and HIV infection. He has established close collaborations with HIV associations in France and in the South. He was named Officer of the National Order of the Legion of Honor in 2010. In 2018, as President of the CCNE, he led the Etats généraux de la bioéthique, which resulted in a summary report and an opinion 129 of the Committee. These documents are intended to enlighten French decisionmakers in charge of revising the Bioethics Law which was adopted at the end of June 2021.

In 2019, he was appointed co-chair "of the Collaborative Group on Social Participation (WHO)". He received the INSERM Honorary Award in 2019. Since March 2020, he is the President of the Covid-19 Scientific Council. Jean-Francois Delfraissy has been president of the National Consultative Ethics Committee (CCNE) since January 2017.

Federico DE MONTALVO JAASKELAINEN

Professor of Constitutional Law an Biolaw at the Law School-ICADE, Comillas Pontifical University (the Jesuits University of Madrid). He holds currently the position of ViceRector of Institutional Relations and General Secretary of the University. He holds, also, the Chair of the Spanish Bioethics Committee of Spain, CBE, since 2018 (ViceChair from 2013-2018). He has been also member of the International Bioethics Committee, IBC, UNESCO, from 2014 to 2021. He was appointed by the Spanish Minister of Health, member of the group of expert for the Spanish Strategy for vaccination against Covid-19. During April 2021 he was the relator of the Report of CBE about the right to choose the vaccine, which was asked by the Spanish government to solve the problems derived from some adverse events during the vaccination campaign and the proposal for a mixed vaccination

In 2007 she has been appointed President of the Austrian Bioethics Commission by the Austrian Federal Chancellor, since April 2020 she is also a member of the Corona Task Force of the Federal Minister of Social Affairs, Health, Care and Consumer Protection of the Republic of Austria.

Since 2016 she is holding the UNESCO Chair on Bioethics at the Medical University of Vienna and serves as Director of Ethics, Collections and History of Medicine.

From 2011 to 2015 she was Vice-Rector for Clinical Affairs at the Vienna Medical University Before that she has been managing director of the (Research) Ethics Committee at the Vienna Medical University (1992-2011). Christiane Druml was member of the International Bioethics Committee (IBC) of UNESCO from 2008 to 2015 and serves since 2006 as Austrian Member and currently as Vice Chair of the Board of the General Assembly of the "European and Developing Countries Clinical Trials Partnership - EDCTP"

Isidoros Karatzas is a biochemist and psychologist by training. After joining the European Commission, he was responsible for the ex-post evaluation of the Framework Programme. Isidoros managed the risk governance research file and was the scientific secretary of the European Research Advisory Board (EURAB), a high-level body that advised the Commission on research policy and research priorities. Currently, he is the head of the Research Ethics and Integrity Sector in DG Research and Innovation. As head of the Sector, he established the Ethics Appraisal process for the research Framework Programmes, initiated advanced training courses on research ethics for Commission staff and the research community and has set up the first European system on ethics checks and follow-up. In addition, the sector oversees the research integrity policy activities, including the relations with relevant stakeholders such as ALLEA, LERU, Science Europe and the business community.

Claude KIRCHNER

Claude Kirchner is emeritus research director at Inria, the French national research institut on informatics and applied mathematics, member of the National Consultative Ethics Committee for health and life sciences, and director of the French National Pilot Committee for Digital Ethics created in December 2019.

His scientific interests and contributions focus on logic and semantic foundations for the design and implementation of robust, reliable and secure digital systems, with applications to cybersecurity. He has been the first director of the Inria Bordeaux – Sud-Ouest research centre from 2008 to 2010, Inria's CEO for science and technology from 2010 to 2014, and has been chairing Inria's operational ethics committee from 2012 to 2018.

Her work explores the social, ethical, and regulatory dimensions of genetic and data-driven practices and technologies in biomedicine and forensics. She holds honorary positions at the School of Social and Political Sciences at the University of Sydney, at the Department of Global Health & Social Medicine at King's College London, at the Centre de recherche en éthique (CRE), University of Montreal, Canada, and at the Centre for Health, Law, and Emerging Technologies (HeLEX) at the University of Oxford. Her latest books are: Personalized Medicine: Empowered Patients in the 21st Century? (New York University Press, 2017), and The Pandemic Within: Policy Making for a Better World (with H. Wagenaar, Policy Press, 2021). Barbara is also involved in policy-related work, e.g. as a member of the Austrian National Bioethics Commission, and as Chair of the European Group on Ethics in Science and New Technologies.

Gabriela RAMOS

Gabriela Ramos is the Assistant Director-General for the Social and Human Sciences of UNESCO, where she oversees the institution's contributions to building inclusive societies. Her mandate includes tackling economic inequalities of income and opportunity, and promoting social inclusion and gender equality. She also oversees the youth support agenda, promotion of values through sport, fight against racism and discrimination, and ethics of science, including of neurotechnology and the internet of things. She has overseen the development and adoption of the first global instrument to promote the ethics of artificial intelligence, adopted by acclamation in 2021 by UNESCO's General Conference. She also launched the Global Forum against Racism, to catalyse the political support that member countries have given to this cause. On gender, she has advanced several initiatives, particularly to combat gender stereotypes and biases, including in new technologies.



Previously, Gabriela Ramos worked as Cabinet Director and Sherpa for G20/G7APEC at the OECD, contributing to increasing the OECD's global impact and leading key initiatives such as "Inclusive Growth", "New Approaches to Economic Challenges", "Climate Change and Growth", the gender strategy and work on well-being and children. At the G20, she contributed to the international reform of tax systems; the adoption of the gender quota (to reduce the labour gap) and the establishment of the W20; and the adoption of the principles of artificial intelligence, among others. She also oversaw Global Relations and the OECD's membership enlargement process.

In 2019, she launched the Business for Inclusive Growth (B4IG) platform, bringing together 40 multinational companies committed to reducing inequalities. Previously, she was Director of the OECD Office in Mexico and Latin America where she supported reforms in education, telecommunications, gender and health. She was a member of the Mexican Foreign Service.

In 2013 she was awarded the Order of Merit (Ordre du Mérite) by the President of France. Her work to promote gender equality has earned her several awards including from Forbes and Apolitico. She has been a Fulbright and Ford McArthur Fellow. She is an alumna of Harvard University's Masters in Public Policy and Universidad Iberoamericana's BA in International Relations. She is a board member of the "Paris Peace Forum"; the "UNICEF Advisory Board"; as well as the "Lancet Commissions on COVID and on Men's Violence against Women", and member of the Danone "Entreprise à Mission" Committee.

In 1998, she moved to the newly established Department for patients with lung disease and allergy in the University Medical Centre Ljubljana (UMCL), which it until then did not exist. After several years, with its expert clinical and research work, it became the Clinical Department for Respiratory and Allergic Diseases, UMCL.

In 1998, she was elected to the title of assistant to the subject of internal medicine and pulmonology at the Faculty of Medicine of the University of Ljubljana and she became Associate Professor in 2012. She conducted research and introduced several methods for early detection of lung cancer, she introduced many new diagnostic and therapeutic methods of interventional bronchology in Slovenia. She has researched in the field of sarcoidosis in the last 15 years. She has over 40 published original scientific articles, 2 chapters, 3 invited lectures, over 35 published abstracts. She was coordinator of postgraduate seminars in the field of difficult intubation using endoscopy with bronchoscope for residence, specialists for anesthesiologist and run the school of bronchology for doctors in intensive care.

Joeri TIJDINK

Joeri Tijdink is a psychiatrist and Principal Investigator at the Ethics, Law and Humanities department of the Amsterdam UMC, location VUmc and an Assistant Professor in the Philosophy Department (Faculty of Humanities). His main research focusses on research integrity, mental health in academia, research culture, publication pressure, open science, the validity of clinical trials and assessment of research and researchers. He is currently leading a workpackage in the EU-funded SOPs4RI-project that creates policy for research performing and research funding organisations and is an advocate for improving mental health in academia with a focus on early-career researchers. He is also the author of the self-help book Scholar on the Sofa, how to survive in academia (2019). Apart from his work as a researcher, he is a practicing clinical psychiatrist and was recently appointed as member of the Young Academy in the Netherlands (2022). He also cofounder and chair of De Jonge (www.dejongepsychiater.nl), a not for profit organization that discusses and promotes research in psychiatry.
